AFFIDAVIT OF NAME CHANGE

Instructions:

1. Begin the affidavit using your former name exactly as it appears on your stock certificate.
2. Fill out the affidavit using your current name. Your new stock certificate will be issued in this name. Complete the form using your name as you wish it to appear on your stock certificate.

Example: Anna Bell Lee, instead of Anna B. Lee.

3. If you are requesting your stock certificate be changed because your name was legally changed, state the nature of the legal action.

Example: marriage, divorce, adoption or legal change of name.

4. You must provide a copy of supporting documents as proof of name change.

Examples: Marriage certificate, divorce decree, adoption papers, or official name change documents.

5. Provide a copy of your new drivers license.
